Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: Observed inner side of the ice machine has pink mold like substance (not in contact with ice).

[CA] Regularly clean the inside of ice machine to prevent cross contamination.

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: Hot running water at both restrooms were at 70 F.

[CA] Adjust hot water heater to provide hot running water at minimum of 100F at the hand washing sinks in the restroom.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed shelving unit above the janitorial sink with jugs.

[CA] Move the jugs from the janitorial area and clean and sanitize all the jugs before using.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Observed drain pipes from the ice machine and small sink in front area for ice cream are inside the floor sink.

[CA] Provide minimum of 1 inch air gap from the rim of the floor sink to prevent sewer backing up into equipments.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Observed unused equipment such as dough machine, BBQ machine, and containers at the facility.

[CA] Remove unused equipment from the premises to prevent vermin harborage.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed damaged wall near floor in the back storage room.

[CA] Provide smooth, easily cleanable wall with base coving to prevent vermin entry.
