Overall Comments:

This is the first follow up inspection. Any and all subsequent inspection shall be billed at \$282/hour, minimum one hour, during normal business hour, Monday - Friday 7:30 AM to 4:30 PM, and \$645 for a minimum of two hours, during non-business hours, and upon inspector availability.

A vermin checklist for reopening, two pest control reports, and proof of corrections for exclusionary measures were provided prior to this inspection.

Observations:

- A single dead cockroach on the walkway of the market was observed. No evidence of cockroaches observed inside the facility.

- Facility has sealed gaps under the counters and fixed the broken tile.

Facility is okay to reopen.

Discussed with facility operators the major violations observed during the limited inspection. A routine inspection to be conducted in the near future to verify compliance with violations.

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
