## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

**Inspector Observations: Couple of dead cockroaches were observed on the traps and below the upright fridge.**  
**[CA] Eliminate all insects and rodents from the facility by a legal method.**

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

**Inspector Observations: The screen cover of the customer's restroom exhaust fan has excessive dust accumulation.**  
**[CA] Clean the exhaust fan and makeup air screens regularly**

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

**Inspector Observations: There was no functional thermometer inside of the double door under counter fridge.**  
**[CA] To monitor the ambient air temperature of the units, please install a functional thermometer on all refrigeration units.**
