## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations:**

**Lack of Food Safety Certificate.**

**[Corrective Action] Food facilities that prepare, handle, or serve non-prepackaged potentially hazard foods shall have a valid Food Safety Certificate available for review at all times.**

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations:**

**Potentially Hazardous Foods in the walk-in cooler measured at 45 degrees Fahrenheit. Per employee, the walk-in was reading at 39 degrees this morning and temperature must have went up due to frequent opening.**

**[Corrective Action] Ensure Potentially Hazardous Foods are maintained at 41 degrees or below.**

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

**Inspector Observations:**

**Grime accumulation on the handles of the refrigeration units.**

**[Corrective Action] Thoroughly clean and maintain clean.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations:**

**Observed squid thawing in the 3 compartment warewash sink.**

**[Corrective Action] The 3 compartment sink shall be used for warewashing purposes only.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations:**

**Grime accumulation on the floor in the walk-in freezer.**

**[Corrective Action] Thoroughly clean the floor in the walk-in freezer.**
