### Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Lack of paper towels at the handwash sink in the restrooms.**

**[Corrective Action] Ensure paper towels are available at all times at the handwash sink.**

**[Corrected on Site] Employee re-filled paper towel dispenser in the restrooms.**

**Heavy grease accumulation in the hood filter above the deep fryer.**

**Heavy grease accumulation on the floor next to the deep fryer.**

**[Corrective Action] Thoroughly clean and maintain clean.**
