Major Violations

Inspector Observations: Hot running water for women & men's restroom was at 78F.

[CA] Hand washing facilities shall be equipped to provide minimum 100°F water and maximum 108F under pressure for a minimum of 15 seconds.

Inspector Observations: Two compartment food prep sink is leaking from the faucet.
