Comments and Observations

Major Violations

No major violations were observed during this inspection.

Inspector Observations: The dish machine reached 99 degrees F. [CA] The water at the dish machine must reach 120 degrees F.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: The inside upper panel of the ice machine has accumulated mildew-like substance. [CA] Wash and sanitize the inside of the ice machine.
