K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: In the kitchen area, observed a live cockroach on the right side of the cookline, and a nymph cockroach on the left side of the cookline. On the left side of the steam table, in an open crevice on the side of the wall, observed multiple live cockroaches. By the left side of the steam table, in the electrical covering for the white wires attached to the mounted television, observed multiple live cockroaches in the covering tube. At the 3 compartment sink, observed multiple live cockroaches on the left between the wall and the 3 compartment sink. [CA] The premises of the food facility shall be kept free of cockroach activity. A food facility shall not operate when there is a cockroach infestation that has may have resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). The food facility shall cease operation immediately. The food facility shall remain closed until: there is no longer evidence of a cockroach infestation; all contaminated surfaces have been cleaned and sanitized; pest control has service the facility; and contributing factors such as cleaning, sealing of cracks and crevices, and the elimination of harborages have been resolved.

First follow-up inspection is provided free of charge, but all subsequent inspections shall be charged at a rate of \$219.00 per hour. Evening and weekend inspections are charged at a rate of \$493.00 per hour.

CLOSURE / PERMIT SUSPENSION NOTICE

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>8/30/2021</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
