Upon arrival, observed sanitizer is filled in the middle sink of the 3 compartment sink. Per PIC, sanitizer filled to be like a sanitizer bucket. No active warewash observed at the time of inspection. Reviewed warewash procedures with PIC. Warewash stickers was given at the time of inspection.

No major violation observed at the time of inspection.
