K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations:

In the bar area, at the only hand wash sink in the facility, there was no soap available.

[CA] Provide handwashing cleanser in dispenser at handwash stations at all times.

[SA] PIC provided a pump bottle of soap for use.

Minor Violations

No minor violations were observed during this inspection.
