Comments and Observations

Major Violations

K15 - 8 Points - Food not obtained from approved source; 113980, 113982, 114021-114031, 114041

Inspector Observations: The grape 6 grape marmalade is not labeled. [CA] The grape marmalade must not be sold since it does not have a label on the containers. According to the owner the permitted store in San Mateo County will give her labels this week.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: There is not any FSC employee. [CA] At least one employee must have a food safety certificate.

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: The hot water at the dish sink reached 115 degrees F. [CA] The water must reach 120 degrees F.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: There are no test strips for checking the sanitizer. [CA] Provide test strips to monitor the concentration of the sanitizer.
