### Major Violations

K21 - 8 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

**Inspector Observations: FOUND THE HOT WATER AT THE 3 COMPARTMENT SINK AT 73F. [CA] PROVIDE HOT WATER AT 120F MINIMUM.**

### Minor Violations

**Inspector Observations: FOUND MOLD LIKE SUBSTANCE ON THE SHELVES IN THE WALK IN COOLER. [CA] CLEAN THIS AREA MORE OFTEN.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: FOUND A HOLE ON THE WALL NEAR THE RESTROOM. [CA] REPAIR HOLE.**

### Overall Comments:

**NOTE: THERE IS NO HOT WATER AT THE 3 COMPARTMENT SINK. DISCONTINUE BAGGING THE ICE.**
