Major Violations

An employee unable to provide Food Handler's Card for review. [Corrective Action] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.

Inspector Observations:

Dumpster lids observed open. [Corrective Action] Keep the dumpster lid closed when not actively throwing away garbage.

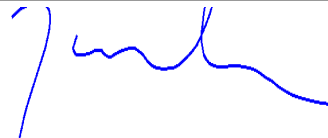
