K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: *The wiping towels were checked at approximately 100ppm. [CA] The quat must be changed out often enough to keep at 200ppm. According tot he mgr it was going to be changed. Adjust time to change them out to keep it proper sanitizing levels and use the test strips to monitor.*
