## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

**Inspector Observations: There was some slim buildup inside the ice machine.**

**[CA] Clean the internal part of the ice machine immediately.**

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

**Inspector Observations: There is a heavy dust accumulation on the screens of the restroom's make-up air exhaust fan.**

**[CA] Clean the dust accumulation on the screens immediately.**

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

**Inspector Observations: Some utensils were stored on the only handwash sink located in the facility.**

**[CA] Dedicate the handwash sink for employee handwashing purpose only. Do not store any utensils on the handwash sink.**
