## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Hand wash station next to the 3-compartment sink is blocked and not operational. Per PIC, they are in the process of getting it fixed.**

**[CA] Hand washing facility shall be clean, unobstructed, and accessible at all times.**

**[SA] Facility has an additional two hand wash stations within the prep area.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Damaged floor tiles next to the walk in freezer. Per PIC, they have reported the issue and are awaiting for contractor.**

**[CA] Replace broken floor tiles with a smooth and of durable construction and nonabsorbent material that is easily cleanable.**
