### Major Violations

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: Observed open bulk food items, such as pasta, located in the dry storage area. [CA] Store open bulk foods in approved NSF containers with tight fitting lids.**
