Major Violations

No major violations were observed during this inspection.

Minor Violations

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Bulk containers of white powder (flour) are not labeled.

[CA] Working containers holding food or food ingredients that are removed from their original packages shall be identified with the common name of the food if not easily recognizable.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Ice scoop handle stored in a way that's touching the ice in ice machine

[CA] Handle to ice scoop shall be stored so that it is not in direct contact with ice.

Observed bowls were used in bulk container.

[CA] Use approved utensils such as scoops or spoons with handles to ensure hands do not come in direct contact with food.
