Inspector Observations: Observed food preparation conducted in three compartment sink. [CA] Discontinue preparing food in three compartment sink, use preparation sink only.

Inspector Observations: Toilet paper was not in dispenser in restroom. [CA] Toilet tissue shall be provided in a permanently installed dispenser at each toilet.
