## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Inside the warewashing room: observed a bottle of bleach stored inside the handwash sink. Observed a large garbage bin stored in front of the handwash sink. Employees stated the items were placed there temporarily for cleaning.**

**[CA] Handwash sinks must be unobstructed and easily accessible to make handwashing not only possible, but likely. Do not store items inside handwash sink.**

**[COS] The bleach bottle and garbage bin were removed.**
