Comments and Observations

Major Violations

K14 - 8 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: Observed build of mold like substance inside red water/soda dispenser.

[CA] Wash, rinse and sanitize the dispenser.

[COS] PIC removed the dispenser top to wash.

Accumulation of brown mold like substance on inside panel of ice machine.

[CA] Clean and sanitize the ice machine and maintain in good condition.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: *Repeat violation

Lack of food safety certificate in the facility.

Food facilities that prepare, handle, or serve non-prepackaged potentially hazard foods shall have a valid Food Safety Certificate available for review at all times.

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Observed old droppings behind water heater in back storage area.

[CA] Clean and sanitize area of dead cockroaches or old droppings.
