A follow-up inspection was conducted to verify major violation (K23: no pest or vermin) is in compliance.

K23: Observed one dead cockroach under the refrigeration unit in the dry storage room. No live cockroaches observed in the facility.

K45: Cove base under the cooking equipments observed repaired. Cracks between the mop sink and the wall observed sealed. Power strip above the work station observed removed to prevent harborage of pest.

Other major violations were not observed due to facility not operating.

Continue to work on compliance of other violations noted on routine inspection conducted on 02/28/2024.
