Follow-up for routine inspection conducted on 7/9/24.

Verified that the following major violations are still in compliance:

- All handwash sinks have water, soap, and single-use paper towels available.
- Potentially hazardous foods are measured at proper holding temperatures (See measured observations). Tea eggs has been removed from menu and not present at time of inspection.

At time of inspection, discussed and provided TPHC handout to operator.

Also discussed that if menu changes with addition of preparing or cooking of potentially hazardous foods - permit category may need to be updated. The addition of any new cooking equipment will require submittal to this department's Plan Check for review and approval prior to installation or use.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **7/25/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
