Several dead roaches were observed including on the dish sink. The hand wash sink is still blocked with the ice machine. Hot water tested at 110 degrees F at the dish sink. It must reach 120 degrees F. The facility is to remain closed.

CLOSURE / PERMIT SUSPENSION NOTICE
