Overall Comments:

On-site to conduct a follow-up inspection to the facility closure (dated 10/15/2025).

The following major violations have been corrected:

- K14: Food contact surfaces clean and sanitized. Per PIC, technician arrived and repaired mechanical dishwasher. Retested chlorine sanitizer solution at 50 ppm during warewashing.
- K22: Sewage and wastewater properly disposed. Observed liquid waste from the 3-compartment sink is now properly draining into drainpipes and does not overflow onto the floor. The gaps in drainpipe have been sealed with sealant.

Facility is hereby authorized OPEN by this department.

At the time of inspection, verified that facility is able to provide the following services for MFF operations:

- Warewashing operations: 3-compartment sink and mechanical dishwasher.
- See limited inspection report (10/15/2025) for other provided services.

Facility is approved for use as a commissary.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **10/29/2025**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
