- No food was left outside or in deep fryer basket

- No food appeared to be adulterated

Two dead cockroaches present on floor behind deep fryer. Facility appears to have sealed bottom wall panel next to prep sink. Facility has pieces of sticky traps present throughout prep area.

Facility is re-opened.
