Comments and Observations

Major Violations

K08 - 8 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: *Observed potentially hazardous food located in a warmer that measured in the temperature danger zone (sushi rice 109F). According to PIC, the sushi rice is under Time Control, but staff forgot to label it. [CA] When using time control, PHFs must be time marked for 4 hours and any remaining food after the 4 hour mark must be discarded. [COS] PIC time marked the rice.*

Minor Violations

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: *Observed fish located in the freezer that was uncovered. [CA] Protect food by covering.*

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: *Two lights under the hood have burned out. [CA] Replace lights.*
