Inspector Observations: Observed two dying juvenile cockroaches; one one wall near water heater and one next to water heater. PIC killed the juvenile cockroaches, no other evidence of alive cockroaches.

Observed dead juvenile roaches in janitorial sink, under cooking equipment and near water heater.

[CA] Clean and sanitize area of dead cockroaches. The premises of each food facility shall be kept free of vermin.

A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s).

[COS] PIC killed the juvenile cockroaches.

Reviewed pest control report from 3/12/24. Per PIC, another treatment is scheduled within next few days.

Accumulation of grease and other debris on wall behind water heater, janitorial sink and storage room.

Continue to deep clean the facility to eliminate grease and food debris. Continue to obtain pest control services.


