- Area behind/around reach in freezer area and inside of compressor area of freezer were observed clean
- No additional cockroach activity was observed at this time; identification of cockroach egg casings were reviewed with operator

A reinspection was conducted on this date to also follow up after closure of the facilities in common permit under record ID: PR0441426, which this facility relies on for warewashing.

Facilities in common permit is reinstated and facility okay to operate.

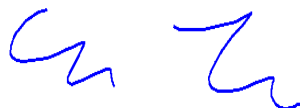
