## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations: Food preparation observed at active warewash sink.**

**[CA] Food preparation shall only occur in approved areas. Use available food preparation sink.**

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: Boxed food found stored on floor.**

**[CA] Food shall be stored at least 6 inches above the floor to prevent contamination.**
