## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: There was no soap supply in one of the handwash sinks located in the kitchen area.**  
**[CA] Please refill the wall-mounted soap supply immediately.**

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations: A lot of open bag contents were observed on the shelf.**  
**[CA] Store all open bag contents in properly labeled bulk containers.**

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: Some food products were stored on the floor in the kitchen area.**  
**[CA] Please store all food products at least six inches off the floor on an approved shelf or dunnage rack at all the time.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: The sanitizing compartment section of the three compartment wash sink was blocked by a cutting board.**  
**[CA] The wash sink must be exclusively used to wash, rinse, and sanitize all reusable utensils. Therefore, do not block any section of the sink.**

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

**Inspector Observations: A lot of open bag contents were observed on the shelf.**  
**[CA] Store all open bag contents in properly labeled bulk containers.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: The floor sinks have some dirt accumulation.**  
**[CA] Conduct a thorough cleaning on the floor sinks regularly.**
