Some spray bottles with chemical cleaners are not labeled.

[Corrective Action] Ensure all bottles are labeled with the contents.

[Corrected on Site] Employee labeled the spray bottles.

Rubber seal on the right door of the 2 door upright cooler observed cracked/ripped.

[Corrective Action] Repair or replace the rubber seal.

Inspector Observations:

Empanadas are covered in trash bag before moving into the single door upright cooler.

[Corrective Action] Use food grade bags to cover the empanadas.
