Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: The soap dispenser at the kitchen hand sink is not working. [CA] Provide soap for proper hand washing. [COS] The employee brought a bottle of soap until the wall mounted dispenser can get fixed.

K22 - 3 Points - Sewage and wastewater improperly disposed; 114197

Inspector Observations: There is a very bad smell in the kitchen. It seems to be the grease trap. [CA] Have the grease trap cleaned out and get rid of the smell.
