### Major Violations

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: 1. Found leaking drain line under warewash sink in back prep area. [CA] Secure leak.**

**2. Found missing cold/hot water knob at warewash sink (left side) in back prep area. [CA] Provide cold/hot water knob.**
