Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Food safety certificate is not available for review upon request [CA] Maintain records of food safety certificate and food handler cards on file within facility and readily available upon request.

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Bucket stored in the kitchen hand sink [CA] Keep sink clear for hand washing

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: No sanitizer detected in the wiping cloth pail [CA] Keep 200 ppm quat sanitizer and 100 ppm chlorine solution in the pail
