Inspector Observations: Unable to provide a current food manger certification at the time of inspection.
[CA] Obtain a new food manger certification within 60-days.

Inspector Observations: Multiple dead cockroaches in the dry storage area on the floor. Per PIC, they think pest are going into facility through roll up doors and have ordered special weather strips to seal cracks properly.
[CA] Clean and sanitize area of dead cockroaches or old droppings.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: 3-Compartment sink is leaking once turned on from faucet area.
[CA] Repair plumbing fixture and maintain in clean and good repair.
