Follow-up inspection to routine inspection conducted on 10/18/2022.

Reviewed invoices for spices and other dry items stored within cardboard 5 gallon containers.

Observed bulk spices, food and the meat within the chest freezer to have been removed from the outside storage area.

Continue working on relocating single use food containers and the two door upright freezer currently in the outside mop area area within the fully enclosed facility. Send pictures to inspector of relocated items by 11/8/2022. If picture is not received a charged follow-up will occur.

Remove unapproved chest freezer, rice shaper and vegetable cutter from the premises.

The first follow-up inspection is free of charge. Subsequent follow up inspections after first follow up shall be billed \$219/hr during business hours and \$493/hr during non business hours upon availability. Failure to comply may result in enforcement action.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
