## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Lack of papertowels in dispenser at hand sink in sushi prep area. [CA] Keep dispenser stocked at all times.**

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

**Inspector Observations: Observed duct tape on a spatula with a missing handle. [CA] Replace broken utensils with new ones. Maintain equipment in good repair. Spatula was discarded in trash.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: Observed several wiping cloths on counters throughout the back and front prep areas. [CA] Store wiping cloths in sanitizer buckets in between uses.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: The faucet at the hand sink in the sushi area is leaking. [CA] Repair the faucet and maintain equipment in good repair.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: Observed a 2-3 inch gap at ceiling where the pipes are located by the back door. 1-2 inch opening on top and bottom of back screen door. [CA] Seal the hole (foam spray) and gaps at the door (screen) to prevent entrance of vermin.**
