**Major Violations**

K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

**Inspector Observations:** *At the front counter, below the espresso machine, on the gray electrical conduit, observed multiple live cockroaches. In the same area, between the counter-top and the wooden base, observed nymph cockroach between worn caulking. Observed pest control report from 5/10/2022. [CA] Facility shall be kept free of cockroach activity. Clean and sanitize all areas with activity. Seal all cracks and crevices to prevent continued harborage. Contact pest control to provide service to facility. Facility shall be free of activity during follow-up inspection. Any observed activity will result in continued closure of facility. Contact district inspector at frank.leong@cep.sccgov.org or call 408-918-1955 for follow-up inspection. Any subsequent follow-up inspections after the first will be charged at \$219.00 per hour. Weekend or after-hour inspections are charged at \$493.00.*

**Inspector Observations:** *At the front counter, observed accumulation of coffee grounds/food debris around the dump hole in the counter-top. [CA] Ensure front counter is cleaned and sanitized to prevent contamination, and possible harborage of vermin.*

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations:** *At the front counter, in the prep areas, observed cracks and crevices between counter-top and wooden base, in cabinets, and underneath handwash stations. [CA] Ensure all cracks and crevices are sealed to prevent harborage of vermin.*

**CLOSURE / PERMIT SUSPENSION NOTICE**

When required to determine compliance, a single reinspection will be conducted without additional charge. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
