## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: Food handler training for employees that conducts ware-washing not provided.**

**[CA]: All employees that handle open food or food contact surfaces shall obtain valid Food Handler Cards within 30 days of employment. Food Handler Cards shall be maintained on site and available for review at all times.**

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Hand sink partially blocked by plastic cups stored in hand sink basin.**

**[CA]: Hand sink stations shall be accessible and unobstructed at all times.**

**Facility has coffee dispensers and machines that need to be ware-washed.**

When required to determine compliance, a single reinspection will be conducted without additional charge.
