2nd follow-up inspection to the routine inspection conducted on 9/24/2025. Food facility was closed due to an active vermin infestation and instructed to cease operation of food sales.

Observations:

- No evidence of a vermin infestation observed in the food facility.
- Hand sink observed fully stocked and unobstructed.
- Holes/gaps have been repaired.
- Heavy accumulation of grime, grease, and food debris observed on cook line and back kitchen area. Per operator, facility will be cleaned before opening today at 5pm. Pictures will be sent via email.
