Inspector Observations: Observed one live cockroach by the preparation sink and janitorial sink. Observed one live cockroach by the mechanical warewash. Observed one live cockroach at the sushi counter. Observed several dead cockroaches byt the mechanical warewash. Observed what appeared to be old rodent droppings by the entrance to the sushi line. [CA] The premises of each food facility shall be kept free of vermin. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). The food facility shall cease operation of the food facility immediately. The food facility shall remain closed until: there is no longer evidence of a vermin infestation; all contaminated surfaces have been cleaned and sanitized; and contributing factors such as cleaning, repairs, and the elimination of harborages have been resolved.

## **CLOSURE / PERMIT SUSPENSION NOTICE**
