**Inspector Observations: FOUND NO PAPER TOWELS IN THE WALL DISPENSER IN THE RESTROOM. [CA] PROVIDE PAPER TOWELS. COS.**

### Minor Violations

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: FOUND SEVERAL BOXES OF BOTTLES DRINKS STORED IN THE RESTROOM. [CA] DO NOT STORE ANY FOOD OR DRINK BOTTLES/CONTAINERS IN THE RESTROOM.**

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

**Inspector Observations: FOUND LOTTERY SCRATCHING RESIDUE ON THE LID OF THE REACH DOWN POPSICLE FREEZER. [CA] CLEAN THIS AREA MORE OFTEN.**

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

**Inspector Observations: THE RESTROOM FAN IS NOT WORKING. [CA] PROVIDE A WORKING FAN.**

**FOUND A NON WORKING LIGHT IN THE SECOND WALK IN COOLER. [CA] PROVIDE A WORKING LIGHT.**

**FOUND EXCESSIVE AMOUNTS OF BOXES AROUND THE MOP SINK. [CA] PROVIDE ACCESS TO THE MOP SINK.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: FOUND THE MOP INSIDE THE MOP BUCKET. [CA] HANG THE MOP TO AIR DRY.**
