## Comments and Observations

### Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: The cheese and corn dogs were in the walk in at 58 and 60 degrees F. [CA] Potentially hazardous food must be held at 41 degrees F and below. The employee threw them into the garbage can. Do not place any PHFs in the walk in.**

### Minor Violations

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Observed the wall behind the dish sink to be deteriorated. [CA] Repair the walls where deteriorated.**

**Observed the wall to be deteriorated where the walls meet the floor. [CA] Repair where needed throughout the back rooms.**
