Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: The front hand washing sink does not give hot water. [CA] Use the other hand washing sink until this sink can give hot water. It must reach 100 degrees F.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the freezer at the cook line to be on deteriorated wood. [CA] Remove the wood and clean the area around it

The plastic dry food storage shelving unit in the kitchen has accumulated food particles and debris. [CA] Clean the shelving unit and the floor around it.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: Observed a few light bulbs out in the kitchen. [CA] Replace the light bulbs so that all areas are brightly lit.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floors to have accumulated debris and food particles behind equipment in the kitchen. [CA] Thoroughly clean the floors mostly behind equipment.

Observed the walls to have accumulated food splashes and debris. [CA] Clean the walk.
