Inspector Observations: In the interior panel of the ice machine: Accumulation of mold-like substance.

[CA] Clean and sanitize ice machine more frequently.

Inspector Observations: Area below the water heater: Three dead cockroaches observed on glue board.

[CA] Clean and sanitize area of dead cockroaches or old droppings.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: In the walk in cooler: Accumulation of debris on fan guards.

[CA] Nonfood-contact surfaces of equipment shall be kept free of an accumulation of dust, dirt, food residue, and other debris.
