Major Violations

No major violations were observed during this inspection.

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Empty paper towel dispenser near front bar area. Napkins available nearby. New shipment will arrive in about two days per employee. [CA] Provide paper towels inside dispenser.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: Observed raw eggs stored above whipping cream and grass jelly in reach-in cooler. [CA] Store foods at correct levels to prevent cross contamination.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Observed boxes and containers of food stored on floor. [CA] Store foods six inches off of floor or on rolling carts.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Observed multiple soiled wiping clothes stored around kitchen counter tops. [CA] Store wiping clothes in sanitizer buckets when not in use.
