Follow-up inspection for closure due to cockroach infestation in the facility.

The following violation(s) was not corrected:

K23M - COCKROACH ACTIVITY

- In the employee service area, observed a single live cockroach on the wall on the right side of the area, and multiple live cockroaches on the top right side in crevices between crown molding and FRP panels.
- In the kitchen area, to the left of the dry storage racks, behind the 3 door reach in refrigerator, observed 3 live cockroaches around the power outlet.
- In the back prep area, above the 3 compartment sink, observed 3 live cockroaches on crevices between wall and ceiling.
- In the back prep area, on the wall/ceiling above the prep table, observed 4 live cockroaches on crevices between wall and ceiling.
- Facility will continue to stay closed. Contact pest control to provide further service for facility. Clean and sanitize all areas with activity.
- Remove all equipment from the kitchen area to allow for further cleaning and preventing areas of harborage. Seal all cracks and crevices to prevent further harborage.
