Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations:

Lack of paper towels in the paper towel dispenser in the restroom.

[Corrective Action] Ensure paper towels are stocked at all times.

[Corrected on Site] Employee refilled the paper towel dispenser.

Minor Violations

K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations:

Lack of time markings for the boba left at room temperature. Per employee, the boba was cooked at 12:00.

[Corrective Action] Ensure boba is time marked with a 4 hour discard time per TPHC written procedures.
