Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Observed lack of paper towels at hand sink in the deli area. [CA] Keep dispenser stocked at all times. [COS] Paper towels were re-stocked.

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Measured individually wrapped sliced deli roast beef at 44F, less than 4 hours. [CA] Maintain potentially hazardous food 41F and below. [COS] Rechecked and temp measured at 41F.
